Leader of the Council	3 rd April 2014	Community Projects Fund - Applications for Financial Assistance	<p>RESOLVED that:</p> <p>(a) subject to the Council's Standard Conditions and the Council being satisfied that the Applicant has taken advice on whether it can work with Bledington Parish Council to mitigate the cost of VAT, the application for grant aid submitted by the Bledington Village Hall Committee towards the cost of renovating the roof of the Village Hall be approved in a sum of £5,000 or 25% of the project cost, whichever is the lower;</p> <p>(b) subject to the Council's Standard Conditions, the application for grant aid submitted by Siddington Parish Council towards the cost of replacing the aerial runway in the village playground be approved in a sum of £2,075 or 25% of the project cost (based on the figures for the lowest of the quotations supplied), whichever is the lower;</p> <p>(c) subject to the Council's Standard Conditions, the application for grant aid submitted by the Lightbourne and Lawrence Educational Foundation towards the cost of re-roofing the front aspect of Whittington Village Hall be approved in a sum of £3,240 or 25% of the project cost (excluding the £200 estimate for insulation), whichever is the lower.</p>
