Background Information

- 1. The Statement of Community Involvement (SCI) was adopted by the Council in January 2007. Subsequent minor amendments were made in May 2010 to Section 13 in order to bring the SCI upto-date and to correct minor errors.
- 2. In light of changes to the on-line planning service to allow representations made in respect of planning and similar applications to be viewed on the Web Site, a minor amendment was made to the SCI in January 2012.
- 3. In order to take account of recent changes to the planning system, and the publication of new guidance, a comprehensive review of the SCI has been undertaken.
- 4. A copy of the revised SCI is attached at **Appendix 'A'**. It complies with the National Planning Policy Framework and the new National Planning Practice Guidance, as well as reflecting the most up-to-date consultation methods and practices used by the Council for Development Management and Local Plan matters.
- 5. Due to the extensive changes to the adopted SCI, it would be appropriate to conduct a period of public consultation. The paper will be made available for public consultation over a six-week period commencing approximately two weeks after the date of this Meeting. Representations received during the six-week consultation period will be taken into account to compile the final document.
- 6. Changes to legislation mean that the SCI is no longer subject to an Examination process with the Planning Inspectorate. The final document will be presented to the Cabinet for consideration of adoption.
- 7. Please note the format of presentation for the final document may change as it is entered into the Council's on-line consultation software.
