#### **Background Information**

- 1. The Statement of Community Involvement (SCI) was adopted by the Council in January 2007. Subsequent minor amendments were made in May 2010 to Section 13 in order to bring the SCI upto-date and to correct minor errors.
- 2. In light of changes to the on-line planning service to allow representations made in respect of planning and similar applications to be viewed on the Web Site, a further minor amendment was made to the SCI in January 2012.
- 3. In order to take account of recent changes to the planning system, and the publication of new guidance, a comprehensive review of the SCI has been undertaken.
- 4. A copy of the revised SCI is attached at **Appendix 'A'**. It complies with the National Planning Policy Framework and the new National Planning Practice Guidance, as well as reflecting the most up-to-date consultation methods and practices used by the Council for Development Management and Local Plan matters. A copy of the Equalities Impact Assessment is attached at **Appendix 'B'**.
- 5. Due to the extensive changes to the adopted SCI, a six-week period of public consultation has taken place. 116 representations were received from over 30 different consultees. A detailed response has been prepared to address the comments and identify changes to be made to the document. The response report runs to approximately 90 pages and a copy will be placed in the Members' Room.
- 6. As a result of the feedback received, minor changes have been made to the document such as additions to the consultee list, added explanation and removal of some sentences to make the document more user-friendly.
- 7. Changes to legislation mean the SCI is no longer subject to an Examination process with the Planning Inspectorate. The final document is being presented to the Cabinet for consideration of adoption.
