Financial Implications

There are none directly associated with this report - the implications of all recommendations fall within existing budget allocations. The budgetary framework for the Joint Waste Team (JWT) is detailed on page 17 Section 8 of the Business Plan.

The proposed Revenue Budget contained in the Business Plan for the JWT for 2015/16 is:

Included in the Business Plan (page 20) are the salary costs associated with the provision of the JWT. These costs are controlled by the Joint Waste Committee. This Council contributes to these costs but this is within existing budget allocations.

	Service budgets relating to the delivery of Environmental Services, including the cost of refuse and recycling collection and street cleansing, are retained by the Council and are not controlled by the JWC. The projected budget allocations for these services are therefore included as part of the Council's normal budget planning process.

Background Information

- 1. In November 2011, the Cabinet agreed to the establishment of the Gloucestershire Joint Waste Committee (JWC).
- 2. On 1st April 2013, the then JWC partners (this Council, Cheltenham Borough Council, Forest of Dean District Council and Gloucestershire County Council) formed the Member-led Committee while staff from the Waste teams within each authority formed the Joint Waste Team (JWT).
- 3. The Cabinet authorised the JWC to undertake this Council's functions in relation to the collection, management, disposal treatment, or recycling of waste and street cleansing but it retained a number of decisions (contained within Paragraph 3.2 of the report to the Cabinet on 3rd November 2011) including: "...Budget setting: retaining the annual decision on budget setting as part of the business planning process for the Gloucestershire Joint Waste Committee. .."
- 4. In June 2014, the Cabinet agreed to complete the new Inter-Authority Agreement following the addition of Tewkesbury Borough Council as a new partner to the JWC. Tewkesbury Borough Council joined the JWC in December 2014.
- 5. This Council still currently holds the budgets for Cotswold waste functions, which are managed by the JWC.
- 6. Each year, the JWC formulates a revised Business Plan and supporting financial plan, in conjunction with the Strategic Management Group (Strategic Directors), Strategic Finance Group (Section 151 Officers), and facilitated by the JWT. The Business Plan requires ratification, as a retained decision, by each partner authority.
- 7. Although the Business Plan is in place and sets out the work programme for the year(s), should any emerging priorities or issues arise during the year, we have the ability through the JWC structure to raise these with the Committee at any time.
- 8. The key focus of the Business Plan for the next three years is around the introduction of BID:-
 - Broadening there are currently five authorities on the JWC. The aim is to form a JWC with all authorities by 31st March 2016;
 - Integration to seek savings and efficiencies through promoting common systems and objectives, where appropriate, across all areas of activities;
 - Diversion to encourage waste minimisation and reuse, maximise recycling and reduce waste to landfill.
- 9. The Action Plan attached at **Appendix 'A'** focuses on the delivery of actions to support this focus. The increase in Waste arising set out in Section 4.5 Challenges, illustrates the importance of diversion to ensure targets are met.
- 10. A key piece of work for the JWT for 2015/16 will be to continue to support the Council in the development of a permanent Environmental Services and Waste Depot facility for Ubico Ltd., and the subsequent operational decision to transfer of the joint Cotswold/West Oxfordshire District Councils' Animal Control service to the new facility as part of the West Oxfordshire District Council Depot transfer to Ubico Ltd. in April 2015.
- 10. The JWC approved the Business Plan for 2015-18 at its Meeting held on 10th February 2015
