## COTSWOLD DISTRICT LOCAL PLAN SUBMISSION DRAFT REG.19 APRIL 2016

With reference to paragraph 1.7 of the previously-circulated report - as a result of the informal meeting with the Planning Inspector, and reflecting on the most appropriate response to building in flexibility and contingency for land supply throughout the plan period, it is recommended that further sites are brought into the list of allocations. These are in addition to those identified in the January 2015 consultation and are a key update from Informal Cabinet. All of these sites have been reviewed as part of the SHLAA process to establish that they are suitable and available for development within the plan period and therefore represent a sound strategy for delivery of the OAN.

A brief Update Note, which identifies the recommended additional site allocations, is attached (along with associated plans).
