## 1. BACKGROUND

- 1.1. Prior to, and following, the establishment of Publica, various reports have been presented to Members in relation to the structures around, and operational arrangements in respect of, commissioning. It has been acknowledged that the situation would evolve over time, and the arrangements would be reviewed and refined in the light of experience.
- **1.2.** The Council's Statutory Officers and the Managing Director and Executive Director (Commissioning) of Publica have been undertaking further work to produce a high-level Commissioning Framework document.
- 1.3. The document seeks to (i) clarify and strengthen the different roles of the Council and Publica (and their respective lead officers); (ii) set out the over-arching requirements in relation to robust performance data and analysis, so that the Council can properly hold Publica and other service providers to account; and (iii) reinforce the assurance elements.
- **1.4.** The document also has regard to the comments on commissioning that flowed from the Corporate Peer Challenges at Forest of Dean and West Oxfordshire District Councils, and also reflects on the details of my sessions as part of our peer challenge (including feedback sessions).
- **1.5.** It is accepted that this document will need to be underpinned and supported by more detailed documents, but the framework sets the principles to move forward.
- **1.6.** Following initial informal discussion by Cabinet Members, the document was then considered by the Overview and Scrutiny Committee at its Meeting held on 3<sup>rd</sup> December 2019 and that Committee endorsed the document as a positive step forward in clarifying the overall commissioning process.
- **1.7.** The updated document is set out at Annex A and is presented for formal consideration, sign-off and implementation.
