Purpose of Report	The report details proposed revisions to the Council's Statement of Licensing Policy under the Licensing Act 2003 ('the Act'), based on legislative requirements and statutory guidance.

Background Information

1. <u>General</u>

1.1 The Council is the Licensing Authority for the purposes of the Act. The Act sets out the regulatory system that governs the provision of all alcohol, late night refreshment and entertainment premises in England and Wales. It requires the Council to prepare a Statement that it proposes to apply in exercising its functions under the Act.

1.2 The Statement is a licensing policy which sets out the general approach the Council will take when carrying out its regulatory role under the Act. This should be kept under review and must be re-published every five years.

1.3 The Act contains four licensing objectives, which underpin the functions that the Council and other Responsible Authorities will perform. These Objectives are central to the regulatory regime created by the Act. They are:-

- The prevention of crime and disorder;
- The protection of children from harm;
- Public Safety;
- The prevention of Public Nuisance.

1.4 The current Statement of Licensing Policy is due to expire in January 2016, and a new one must be in place by 7th January 2016.

1.5 The Act provides that the Licensing Authority must consult with:-

- The Chief Officer of Police for the area;
- The Fire and Rescue Authority for the area;
- Persons/bodies representative of local holders of premises licences;
- Persons/bodies representative of local holders of club premises certificates;
- Persons/bodies representative of local holders of personal licences; and
- Persons/bodies representative of businesses and residents in its area.

1.6 A table of proposed amendments to the policy are attached at **Appendix 'B'**.

1.7 The document has been subject to a nine- week public consultation period - this ended on Friday 16^{th} October 2015.

1.8 Details of the responses received are attached at **'Appendix 'C'** - a comment is provided against each response as to how the document has been amended, or a reason why an amendment is not considered appropriate.

2. Planning and Licensing Committee

2.1 The Planning and Licensing Committee met on 11th November 2015 and discussed the responses.

2.2 Councillor Robert Dutton suggested that an amendment be made to paragraph 5.6 so that the sentence reads: 'The Council requires' rather than 'The Council encourages'. This change was agreed by all Members of the Committee. This was the only change made to the draft document presented to the Committee, and has been incorporated within the document at **Appendix 'A'**.

2.3 Members resolved to present the draft Statement of Principles to Council for approval.
