#### Chairman and Vice-Chairman of the Council

(2) The nominations received in respect of these positions (Annual Council Meeting, Agenda Items (3) and (4)) are attached - **page 5**.

#### Strong Leader and Cabinet Governance Arrangements

- (3) The Council operates the Strong Leader and Cabinet form of governance. The Cabinet comprises the Leader of the Council, together with up to nine other Members to be appointed by the Leader (one of whom shall be appointed as Deputy Leader). The Leader is elected by the Council, for a four-year term.
- (4) Councillor Lynden Stowe was elected Leader of the Council for the four-year term at the Annual Meeting of the Council held on 19<sup>th</sup> May 2015. However, Councillor Stowe has indicated that he will stand down as Leader with effect from this Annual Meeting. As such, the Council will be asked to appoint a new Leader, to hold office for the remainder of the Council term.
- (5) Councillor MF Annett is the nominee of the Conservative Group for the position of Leader of the Council **page 6** (Council Meeting Agenda Item (7) refers). Subject to his election by the Council, the appointments to the Cabinet made by Councillor Annett are attached **page 7** (Council Meeting Agenda Item (8) refers). Such appointments are purely for information/noting.

#### **Committee Memberships** (Annual Council Meeting Agenda Item (9))

- (6) With the exception of the Cabinet, the Regulations in respect of political proportionality on Committees will apply (the 'Widdicombe Rules').
- (7) Based on the number of Members across each group, the following allocation of seats is suggested across those Committees that are subject to the 'Widdicombe Rules':-

- (8) It is for the political groups to make their own decisions regarding the allocation of Committee places to their members (within the overall allocation of seats); and the allocations made are attached pages 8-10.
- (9) A Member of the Cabinet is <u>not able</u> also to serve on the Audit Committee or the Overview and Scrutiny Committee; but is able to serve on the Planning and Licensing Committee.
- (10) The Chairman of the Council is <u>not able</u> to serve on the Cabinet or any Committee.

(11) The Vice-Chairman of the Council is <u>not able</u> to serve on the Cabinet; but is able to serve on any Committee.

#### Chairmen Etc. Nominations and Chairmanship Etc. Restrictions

- (12) The Chairman of the Council, by virtue of office, is <u>not eligible</u> to hold office as a Chairman of a Committee during his/her term.
- (13) No Member of the Cabinet is entitled to hold the office of the Chairman or Vice-Chairman of a Committee.
- (14) No Member of the Council is entitled to hold the office of the Chairman of more than one Committee at any time.
- (15) No Member of the Council is entitled to hold the office of the Chairman of the Council or the Chairman of any Committee for a continuous period of more than three years. Nor is he/she eligible to be a Chairman or Vice-Chairman of any Committee within one year of ceasing to hold office as Chairman of any Committee.
- (16) A nominee for election/appointment as a Chairman or Vice-Chairman (of either the Council or of a Committee), or as Leader of the Council, is not required to be present at the Meeting at which the election/appointment is to take place.
- (17) There is no requirement for a secret ballot to be held in respect of voting on Member appointments.
- (18) With the exception of the Planning and Licensing Committee, all Committee Vice-Chairmen positions have been dispensed with.
- (19) The nominations made in respect of the Chairman and Vice-Chairman of the Council, the various Committee Chairmen positions, and the Vice-Chairman of the Planning and Licensing Committee, are attached **pages 11-13** (to be dealt with by each Committee in turn at the close of the Annual Council Meeting).
