Options for Joint Working

This is an Update to the Corporate Strategy for this Council only. However, the Council's approach to joint working generally is dealt with in the Update.

Background Information

1. In February 2016, the Council agreed a Corporate Strategy for the period 2016 to 2019. The Strategy set out the Council's Aim and Priorities as follows:

Aim:

To be recognised as the most efficient council in the country

Priorities:

- 1. Provide high quality services at the lowest possible cost to Council Taxpayers;
- 2. Protect and enhance the local environment whilst supporting economic growth;
- 3. Champion issues which are important to local people.
- 2. The document is reviewed on an annual basis. The draft Update to the Corporate Strategy for 2018/19 includes a re-statement of the Aim and Priorities, a summary of how we are addressing our challenges, and progress on the Council's efficiency measures and the top tasks for 2018/19.
- 3. The 2018/19 Update was considered by the Cabinet on 19th July 2018; and the Cabinet commended the recommendation as presented to the Council for approval. In expressing support for the Update, the Cabinet considered that it was fit-for-purpose given that it related to the final year of the Council term.
