Every Friday we transport up to fifteen people to do their weekly shopping in either Stow on the Wold, Banbury, Evesham or Stratford on Avon as there is no affordable shopping outlet in Moreton in Marsh for these people. Although there is an Aldi in Chipping Norton it is not possible to gain access to the car park at this store due to the size of our minibus.</p> <p data-bbox="533 1234 1358 1346">With an Aldi in Moreton I am sure these people will use the store for their weekly shopping and will not have to rely on our transport to do it.</p> <p data-bbox="533 1379 1358 1603">An argument that has been put forward is that there is Budgens Food Store in Moreton. But elderly, and not so elderly, people will tell you that it is a very expensive place to shop. It is cheaper for the people we take shopping to make a donation to us and go further afield to do their shopping.</p> <p data-bbox="533 1637 1358 1827">Pensioners and people on low income in the area need an affordable shopping outlet to do their weekly shopping. Also with the increasing number of new houses being built in Moreton in Marsh a suitable local food store, such as Aldi, is a must.'</p> <p data-bbox="533 1861 1358 2047">ii)' Dear sirs , I am writing as I cannot attend the meeting.
