Cllr Angus Jenkinson

Re item: GCC "engaged with Cllr Angus Jenkinson to identify stakeholders in the agricultural sector."

I met with the lead officer responsible for GCC farms, Mark Parker. The rural estate manager is Jill Mathew, who I understand is very competent. Resources for the task are limited. There are currently some 75 tenant farms occupying 7000 acres (average size <100 acres, c40ha). The county intends to reduce this to 5500 acres to release capital to cover the considerable costs, especially in social care which absorbs the majority of the budget. In this sense, it can be said that shortage of funding and scale of problem mitigate the ability of GCC's agricultural sector assets to perform the roles that they might. I discussed such roles as contributing to a) mitigating climate and ecology crises; b) providing one or more agricultural equivalents of the employment hubs to disseminate progressive farming methods (like FarmED); c) education and learning for young farmers who go on to do regenerative farming; d) providing a resilient and nutritious source for short chain food supply for county activities (schools, hospitals...); e) providing a home for local small abattoir(s) for regen and organic farmers needing a traceable source. GCC has developed a GIS system available at CDC.

Forthcoming

- Environment and climate change considerations in the SEDF decision making process has been added to the work schedule.
- Following a request, a focus on the key metrics of the key Economic priorities from the Strategy will be included in every meeting's Economic Dashboard.
- Digital infrastructure will be discussed in September.

Local Growth Plan

The Gloucestershire City Region Board is planning to produce a Local Growth Plan for Gloucestershire. 2 targeted surveys have been launched to address underrepresented groups (the private sector and one targeting 18-15-year-olds).
