#### 5. Exclusion of the Press and Public

## <u>Purpose</u>

For the Sub-Committee to hear any representation and agree whether or not to enter into private session before determining the allegations of breaches of a Parish Council Code of Conduct.

If the Sub-Committee wishes to exclude the press and the public from the meeting during consideration of any of the items on the exempt from publication part of the agenda, it will be necessary for the Sub-Committee to pass a resolution in accordance with the provisions of Section 100A of the Local Government Act 1972 on the grounds that their presence could involve the likely disclosure of exempt information as described in specific paragraphs of Schedule 12A of the Local Government Act 1972.

The Standards Hearing Sub-Committee may maintain the exemption if and so long as, in all the circumstances of the case, the public interest in maintaining the exemption outweighs the public interest in disclosing the information.

# 6. **Determination of Alleged Breaches of the Code of Conduct - Case references 571 and 574** (Pages 13 - 144)

<u>Purpose</u>

To consider allegations that two members of a Parish Council in the Cotswold District Council area have breached the Code of Conduct, and to determine any appropriate sanctions to be recommended to Parish Council should any breach be confirmed.
