### I. EXECUTIVE SUMMARY

**1.1** This report is for members to consider a new application for Hardship Relief to support a local business in addressing its outstanding liability for Business Rates.

# 2. BACKGROUND

- **2.1** Cotswold District Council has the power to consider granting on an individual basis, Hardship Relief to organisations experiencing financial hardship.
- 2.2 Such decisions have historically been considered through the powers delegated to the Deputy Leader and Cabinet Member responsible for Finance. However, in May 2022 it was agreed that any request for such reliefs in excess of  $\pounds 10,000$  should be considered by Cabinet.

# 3. MAIN POINTS

- **3.1** The Council has received one new application from Nexus the Educators Connection Ltd in respect of Hardship Relief in excess of £10,000.
- **3.2** The financial overview of the application is detailed within Annex A, attached to this report.
- **3.3** Established in 1995, their focus is on innovation for education, and covers a wide range of educational needs including literacy, numeracy, early years, art and craft, outdoor play as well as a comprehensive range of handwriting pencils, pens, and stationery.
- **3.4** Nexus provide unique learning tools for primary and nursery schools within the district and beyond. As products need to be physically demonstrated, Nexus is unable to easily sell their products online.
- **3.5** Since the UK's departure from the European Union (EU) and the Covid-19 pandemic, Nexus has described their business as being in a 'free fall' and have struggled significantly to maintain business productivity.
- **3.6** They have lost European business due to the difficulties that the UK's departure from the EU has brought in respect of exports; as well as a lack of manufacturing worldwide, which has prevented the supply of goods to the businesses leading to reduced turnover.
- **3.7** The company accounts ending August 2021 show an overall loss; however, its loss has decreased by 62% when compared to the previous year. The company has also vacated the premises the application is in respect of, moving the majority of their warehouse to Northern Ireland where they are able to service Ireland and the UK without the increased red tape and costs caused by the UK's departure from the EU. They do retain a smaller unit in the South



Cerney Village ward where they employ fourteen local people, and this business rates account is up to date.

- **3.8** Nexus has changed their business model to ensure the long-term sustainability of the business within the district whilst securing local jobs for local people. It has vastly decreased its losses and with some additional support from the district council could help secure its future growth.
- **3.9** The total liability owing is for the 2021/2022 to 2022/2023 financial years; however, the total charge for each year the business has been in occupation is as follows:

- **3.10** The liabilities and subsequent charges were calculated during 2021/2022 following splits and mergers on the business unit and in total Nexus the Educators Connection Ltd has repaid  $\pounds$ 167,498.25, leaving a balance of £33,904.43.
- **3.11** To support the business with its ongoing recovery it is recommended that Cabinet consider awarding a hardship payment of  $\pounds 16,952.21$ , being 50% of the outstanding liability and arranging a repayment plan to recover the remaining  $\pounds 16,952.22$ .

# 4. ALTERNATIVE OPTIONS

# 5. FINANCIAL IMPLICATIONS



- **5.1** The Council is part of the Gloucestershire 50% Business Rates pool, and the costs of awarding rate relief is shared as follows:
  - Central Government 50%
  - County Council 10%
  - District Council 40%

#### 6. LEGAL IMPLICATIONS

**6.1** Section 49 of the LGFA allows billing authorities to reduce the business rates of any local ratepayer where that ratepayer would sustain hardship if the authority did not do so, and it is reasonable for the authority to do so, having regard to the interests of local Council Taxpayers.
