# **EXECUTIVE SUMMARY**

**I.I** To consider the feedback from the consultation carried out for the proposed increase in parking charges.

### 2. BACKGROUND

- 2.1 Cabinet met on the 11<sup>th</sup> January 2024, and gave delated authority to the Deputy Chief Executive in consultation with the Deputy Leader of the Council and Cabinet Member for Finance to authorise the change in the Cotswold District Councils Parking Order.
- **2.2** To make these changes we need to make a Variation Order, where there is provision for public & statutory consultation.
- 3. Availability of consultation information.
- 3.1 The Notice of Proposal was advertised in the local press; The Wilts and Glos Standard on the 8<sup>th</sup> February 2024. It was also sent to the statutory consultees, Town and Parish Councils, Ward members where we have Off Street parking, placed on our website, signs in all the car parks where a proposed change is being made and at the reception of Council Offices at Trinity Road & the Moreton Area Centre.
