NOTICE OF DISCLOSURE OF PECUNIARY AND OTHER INTERESTS

I, MICHAEL DOUGLAS WILKINSON

a Member of BRIMSSIDE Town/Parish Council,

set out below under the appropriate headings the interests which I am required to declare under the Localism Act 2011 and the Council's Code of Conduct and I have put 'none' where either I have no such interests under any heading or I am unaware of such an interest.

PART A

DISCLOSABLE PECUNIARY INTERESTS

Members are required to register not only their own interests but also those of their husband or wife, civil partner or of any person with whom they are living as if husband or wife or as civil partners when such interests are known by them.

1. EMPLOYMENT, OFFICE, TRADE, PROFESSION OR VOCATION

Any employment, office, trade, profession or vocation carried on by you, or those persons referred to above, for profit or gain.

## 2. SPONSORSHIP

Any payment or provision of any other financial benefit (other than from the Town/Parish Council) made or provided within the last 12 months in respect of expenses you (or any of the persons referred to above) have incurred in carrying out your duties as a Member or towards your election expenses. This includes any payment or financial benefit from a Trade Union within the meaning of Trade Union and Labour Relations (Consolidation) Act 1992.

## 3. CONTRACTS

Any contract which is made between you or the persons referred to above (or a body in which you or they have a beneficial interest) and the Town/Parish Council (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.

#### 4. LAND

Any beneficial interest in land which is within the area of the Town/Parish Council.

#### 5. LICENCES

Any licence (alone or jointly with others) to occupy land in the area of the Town/Parish Council for a month or longer.

## 6. CORPORATE TENANCIES

Any tenancy where, to your knowledge, the landlord is the Town/Parish Council and the tenant is a body in which you, or the persons referred to above, has a beneficial interest.

## 7. SECURITIES

Any beneficial interest in securities of a body where:

- (a) that body, to your knowledge, has a place of business or land in the area of the Town/Parish Council; and
- (b) either:-
  - (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
  - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Members are required to register any interest held by the Member only.

## DECLARATION
