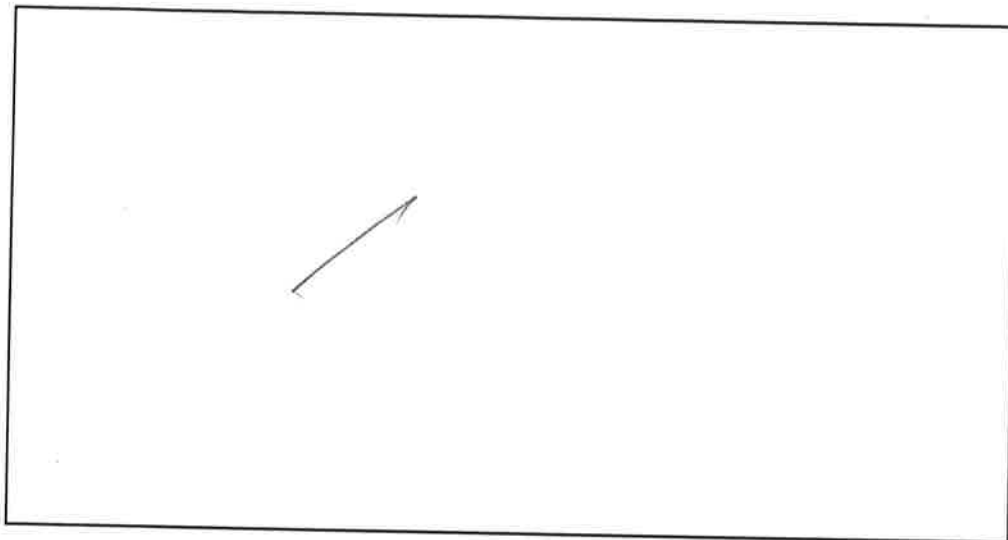

2. SPONSORSHIP

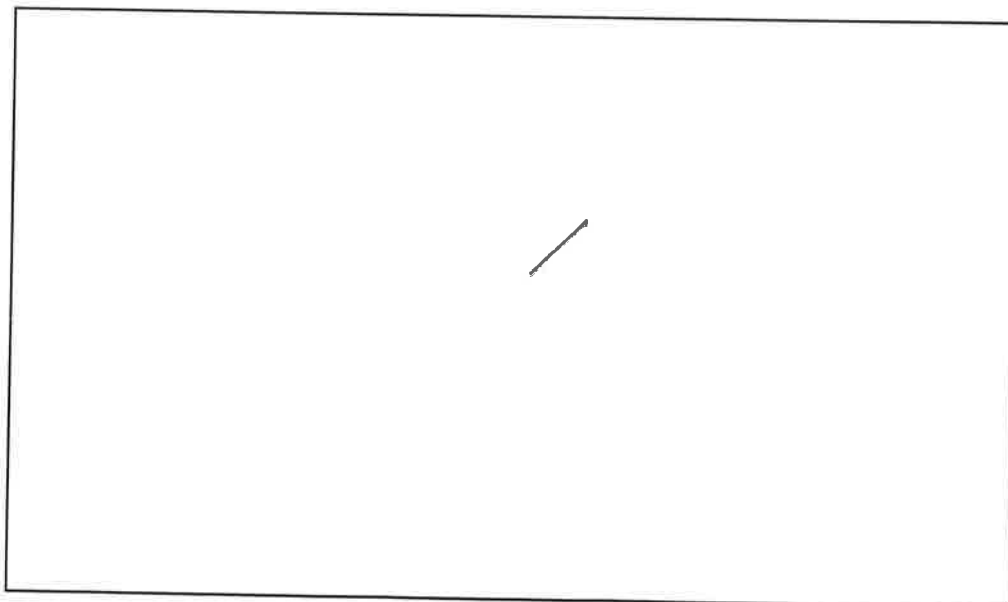

 - (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you, or the persons referred to above, has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

Members are required to register any interest held by the Member only.

Note

The Monitoring Officer of Cotswold District Council is required by law (under the Localism Act 2011 and associated regulations) to establish and maintain a register of interests of members and co-opted members of the District Council and every parish and town council within the Cotswold District.

Members and co-opted members of those authorities are required to provide relevant information to the Monitoring Officer to enable that Officer to fulfil the legal requirements.

The Monitoring Officer, as the data controller of the information provided, will only use such information for the purposes for which it has been obtained and in accordance with legislative requirements; and will look after your personal information securely, following data protection legislation. The data controller will not give personal information about you and the personal information you may provide on other people to anyone else or another organisation unless required by law.
