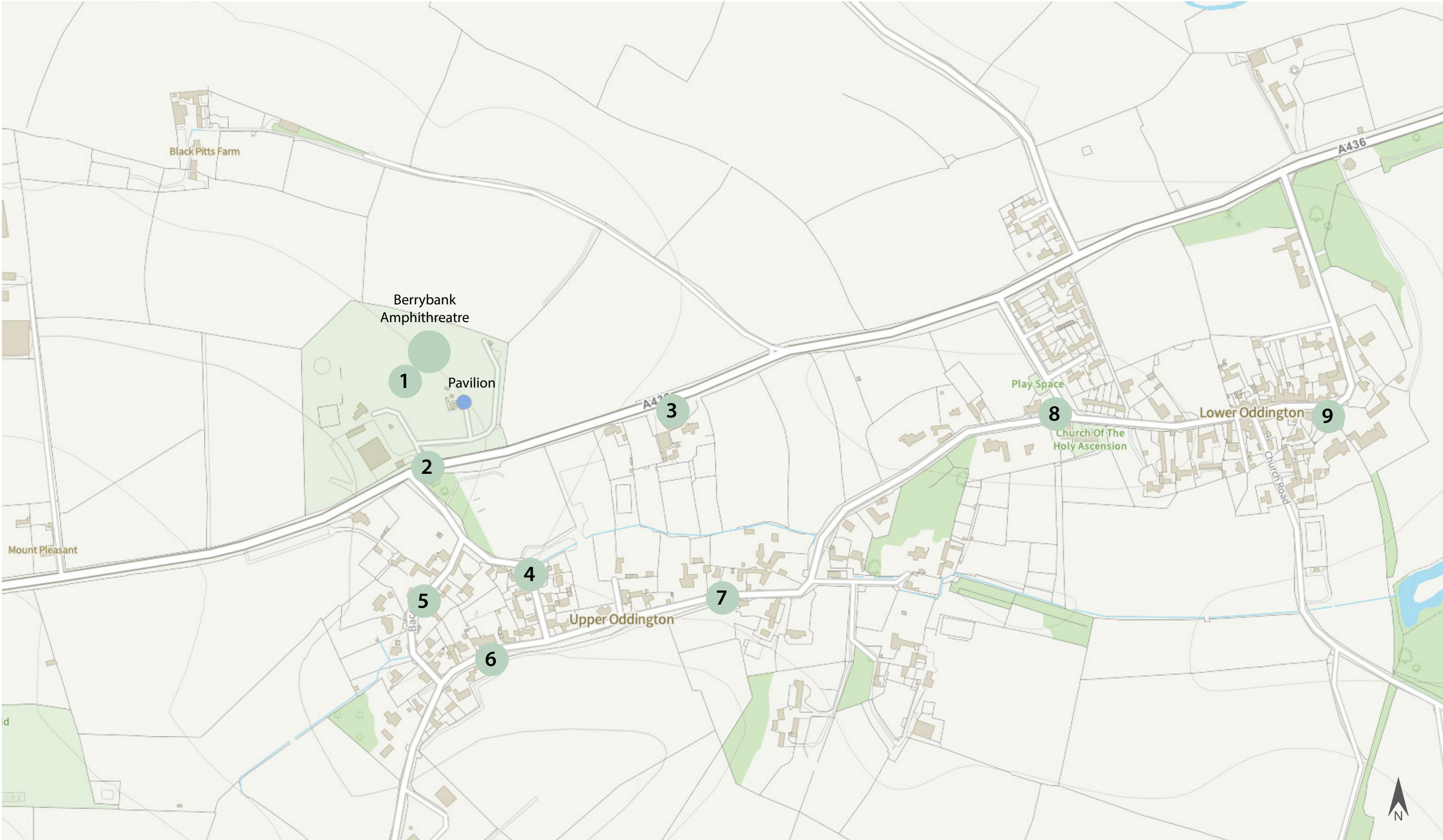

<b>11</b>	<b>22/04303/FUL</b>  (Berry Bank Main Road Oddington Moreton-in-Marsh)	<ul style="list-style-type: none"> <li>• Closest residents to Amphitheatre concerned by noise pollution - sound on occasions intrusive - not able to have windows open</li> <li>• Length of time performers take rehearsing and/or setting up equipment - surely sound levels can be correctly set in fairly short time (25 mins?) and any further rehearsing done at much lower volume.</li> <li>• Whatever sound levels set in Amphitheatre, adjustments made to allow for topography of area and wind speed/direction.</li> <li>• Sound levels should be taken at various points in Oddington and along relevant parts of A436.</li> <li>• Agree with Parish Council stand on this matter. If committee minded to approve applications, Parish Council put forward strict conditions to be placed on operation eg: 79db at perimeter and point source speakers. Noise Management Plan needs to reflect this and remove 110db maximum at front of house</li> <li>• Whilst proprietor keen to find solution, if these conditions cannot be incorporated in any planning consent then would object to the application</li> <li>• If committee approves application hope comments/concerns taken into consideration and incorporated in conditions made to operation of site</li> </ul>
